INHUMAN TREATMENT OR ABUSE OF A HORSE IN ANY MANNER IN THE SHOW ARENA OR ON THE SHOWGROUNDS IS PROHIBITED.

INHUMAN TREATMENT INCLUDES THE SHOWING OF A CRIPPLED, LAME OR INJURED HORSE OR A HORSE WITH ANY HEALTH ABNORMALITY WHICH COULD RESULT IN THAT HORSE'S UNDUE DISCOMFORT OR DISTRESS.

ABUSE INCLUDES EXCESSIVE JERKING, SPURRING, WHIPPING OR ANY OTHER ACT INTENDED TO CAUSE TRAUMA OR INJURY TO A HORSE. ANY ACT OF ABUSE, OR INTENT TO ABUSE, A HORSE IN THE SHOW ARENA OR ON THE SHOWGROUNDS THAT COULD ENDANGER THE SAFETY OF OTHER PERSONS OR ANIMALS WILL BE DEALT WITH IN THE STONGEST POSSIBLE MANNER AS PROVIDED BY THE NCHA RULES.

IF SHOW MANAGEMENT AT ANY NCHA APPROVED OR SPONSORED EVENT DISCOVERS INHUMANE TREATMENT OR ABUSE OF A HORSE, IT MAY IMMEDIATELY BAR THE RESPONSIBLE PARTY AND HORSE FROM ANY FURTHER PARTICIPATION IN THE EVENT. THE DISCRETION OF THE SHOW MANAGEMENT AS TO INHUMAN TREATMENT SHALL BE BASED ON CONSULTATION WITH A VETERINARIAN. IF SHOW MANAGEMENT DETERMINES, IN ITS SOLE DISCRETION, THAT THE WELFARE OF THE HORSE REQUIRES IMMEDIATE ACTION AND A VETERINARIAN IS NOT AVAILABLE, SHOW MANAGEMENT WILL CONSULT WITH THE JUDGE(S) OF THE EVENT BEFORE TAKING ANY FURTHER ACTION ALLOWED BY THIS RULE.
