2. THE SALE HORSE IS NOMINATED BY THE VENDOR AS PROVIDED ON THE ENTRY FORM AND THE FEE OF \$550.00 (INC GST) IS PAID WITH THE ENTRY FORM.
3. IN THE EVENT THAT A YEARLING HAS NOT BEEN NOMINATED BY THE VENDOR THEN THE PURCHASER MAY NOMINATE THE PURCHASED YEARLING AND PAY THE FEE OF \$550.00 (INC GST) AS PROVIDED FOR ON THE BUYER INSTRUCTION SLIP TO THE AGENTS CONDUCTING THE SALE.
4. YEARLINGS MUST BE EITHER SOLD UNDER THE HAMMER OR SOLD THROUGH THE AGENTS BY 5PM THE DAY FOLLOWING THE SALE AND MUST BE NOMINATED AND THE FEE PAID AS PER RULE 2 OR 3.
5. HORSES NOMINATED ON THE ENTRY FORM AND PAID FOR BY THE VENDOR PRE-SALE AND PASSED IN WILL REMAIN ELIGIBLE TO COMPETE FOR THE INCENTIVE PRIZE PROVIDING THAT THE FULL COMMISSION IS PAID BY THE VENDOR TO THE AGENT BY 5 PM THE DAY FOLLOWING THE SALE CALCULATED ON THE RESERVE PRICE SET BY THE VENDOR WITH THE AGENT PRIOR TO SALE IN WRITING.
6. HORSES NOMINATED AND PAID FOR BY THE VENDOR AND PASSED IN AND NO COMMISSION IS PAID TO THE AGENT AS PER RULE 5 THE NOMINATED HORSE WILL BE INELIGIBLE TO COMPETE FOR THE INCENTIVE AND THE NOMINATION FEE OF \$550.00 WILL BE REFUNDED BY THE NCHA TO THE VENDOR.
7. THE NCHA WILL RECOGNISE THE ELIGIBILITY OF THOSE YEARLINGS NOMINATED FOR THE INCENTIVE IN WRITING FOLLOWING THE SALE.
8. ONCE A HORSE IS ACKNOWLEDGED BY THE NCHA AS BEING ELIGIBLE FOR THE INCENTIVE THEN THAT RIGHT WILL BE TRANSFERABLE FROM OWNER TO OWNER IF THE HORSE IS ON SOLD PRIOR TO THE FUTURITY BEING HELD.
