- Little Cutters –12 yos and under. Must be a NCHA youth member (free for 2025) or a day fee is payable (\$35).
- Snafflebit will be re-run cattle.

- Scratchings via I-COMPETE by Thursday 13 February for a full refund
- Entry's and payment via iCompete. Please contact contact NCHA with any iCompete issues (02) 67659356.
- PROGRAM MAY BE ALTERED AT THE DISCRETION OF THE ARHA COMMITTEE. Details provided ASAP to all competitors.
- Every person handling a horse must be a NCHA Member or pay a day member fee of \$35. The \$35 day fee covers whole event.
- AMENITIES FEES OF \$15 PER ENTRY APPLIES TO COVER USE OF FACILITES, GROUNDS, WATER. This is included in the office fee.
- FREE Camping; tape yards OK. No power; please BYO generator. Generator curfew applies. Manure to be piled neatly
- 8NUP NON PRO - Horses aged 8 and older. 8NUP NP payouts as per NCHA Rulebook (plus paying top 3 riders eligible for Rookie/\$7500NP to three places: 1st \$250, 2nd \$150 & 3rd \$100)
