TERMS AND CONDITIONS OF ENTRY

1. Owners and riders must be 'Full' financial members of the NCHA Inc. at the time of nomination and at time of competition.
2. Only registered progeny of subscribed stallions may compete in the NCHA Breeders Incentive events. Copy of registration papers must accompany entry form.
3. All payments include GST.
4. All payments must be on the official forms or 2nd payment may be made via NCHA online services.
5. All nominations will be ineligible to compete until accurate identification is presented.
6. All entries payments must be paid prior to the draws.
7. If outstanding or final payment is not made by due date, the nomination will be regarded as withdrawn and re-entry will only be accepted on payment of late fees.
8. There will be **NO REFUND/CARRY OVER OF ENTRY FEES.**
9. The NCHA Inc reserves the right to cancel these competitions without liability and return all entry fees paid at any time should unforeseen circumstances occur.
10. All scratchings must be in writing and forwarded to the NCHA office by 12noon Monday 6th March 2017. No refunds are applicable after this time.
11. Draws will be posted ten days prior to the start of the show. Refund is applicable for sundry costs prior to draws being posted. Sundry costs only include NCHA Levy, cattle hire, office fee and video hire.
12. Change of ownership does not affect eligibility but the NCHA Inc. must be notified of the transfer.
13. Competitor entry fees and prizes/awards may be subject to change by action of the NCHA Inc. Board.
14. Each event is **one** go round and a Final. 25% advance to final or minimum of 8.
15. 3.5 head of cattle per competitor in the go rounds and 4 head of cattle per competitor in finals.
16. **Finalists will be invoiced cattle hire for the Finals events.**
17. Amateur event to be held (as a class within a class) in conjunction with the Non Pro classes.
18. Highest placing Amateur in each NP class will receive the NCHA Breeders Incentive Buckle.
19. Prize money will be paid to the person whose signature appears on the entry form.
20. Event prizes will consist of The Breeders Incentive trophy for the winners in each class and an editorial on all winners in the NCHA Chatta magazine.
21. Prize money Payouts will be as per NCHA Rule Book and/or Cadusch system.
22. Prize money Payouts will be completed within 30 days from the final day of competition.
23. Any violation of the rules will render the competitor ineligible to collect any prize money or trophy and should the same have already been awarded, must be returned to the NCHA Inc.
