1. Owners and riders must be Full financial members of the NCHA at the time of nomination and competition.
2. Entries and full payment due by 1st February, 2019.
3. Amount payable includes entry fee, office fee, video fee, cattle hire, NCHA Levy and GST.
4. Payouts will be as per NCHA rule book.
5. There will be **NO REFUND/CARRY OVER** of entry fee once draws are done.
6. Payments must be made on or before the due date. Late fees will attract an additional 50% of entry fee.
7. Notice of intention to scratch a horse must be received in writing no later than 5pm, Friday 8th February, 2019. No refunds will be given after this time.
8. The NCHA reserves the right to alter the program should unforeseen circumstances occur.
9. Camping and Stables are to be booked through the NCHA. The opening date for these bookings will be advised closer to the date.
10. To enter a Non Pro event, members must hold a current Non Pro card.
