CONDITIONS OF ENTRY

1. Owners and riders must be 'Full' financial members of the NCHA at the time of nomination and at time of competition.
2. Only registered progeny of subscribed stallions may compete in the NCHA Breeders Incentive events. A copy of the horse's registration papers must accompany entry form.
3. All nominations will be ineligible to compete until accurate identification is presented.
4. All entry fees include Cattle Hire \$135, Office \$80.00, Video \$36.80, Levy \$13.20 and GST.
5. All entries must be on the official form or via the NCHA online entry system.
6. All entry payments must be paid prior to the draws.
7. There will be **NO REFUND/CARRY OVER OF ENTRY FEES.**
8. Late Fees will not be included in the prize money pool.
9. The NCHA reserves the right to cancel these competitions without liability and return all entry fees paid at any time should unforeseen circumstances occur.
10. All scratchings must be in writing and forwarded to the NCHA office by 5pm Friday 8th February, 2019. No refunds will be given after this time.
11. Draws will be posted ten days prior to the start of the show. Refund is applicable for sundry costs prior to draws being posted. Sundry costs include NCHA Levy, cattle hire, office fee and video fee.
12. Change of ownership does not affect eligibility but the NCHA must be notified of the transfer.
13. Competitor entry fees and prizes/awards may be subject to change by action of the NCHA Board.
14. 3 head of cattle per competitor in the go rounds and 3.5 head of cattle per competitor in finals.
15. Each event is one go round and a Final with 25% or minimum 8 advancing to the Final.
16. **Finalists will be invoiced cattle hire for the Finals events.**
17. Highest placing Amateur in each NP class will receive the NCHA Breeders Incentive Amateur Buckle.
18. Prize money will be paid to the person whose signature appears on the entry form.
19. Event prizes will consist of The Breeders Incentive trophy for the winners in each class and an editorial on all winners in the NCHA Chatta magazine.
20. Prize money payouts will be as per NCHA Rule Book and/or Cadusch system and will be completed within 30 days from the final day of competition.
21. Any violation of the rules will render the competitor ineligible to collect any prize money or trophies and should the same have already been awarded, must be returned to the NCHA immediately.
