~ TERMS & CONDITIONS OF ENTRY ~

1. The vendor must be a FULL member of the National Cutting Horse Association.
2. All horses must be available for inspection prior to the sale.
3. Horses must be presented to the satisfaction of appointed association inspectors. The inspectors may reject a horse from the sale if the horse does not comply with the following conditions:
 - a) Markings and brands described on the entry form must be clearly visible and identical to the horse presented for inspection.
 - b) The horse should be prepared and presented suitably for the sale.
 - c) The horse should be free of undesirable characteristics and conformation faults.
4. NCHA reserves the right to restrict the number of entries.
5. Horses for the sale will be selected by criteria.
6. All Vendors are encouraged to submit a video of their horses working at time of nomination, for the selection committee to view and decide suitability to the NCHA Select Sale.
7. There will be no refunds on acceptance of nominated horse/s into the Select Sale Catalogue.
8. Vendors are advised that in line with the NCHA Drug Policy on prohibited substances in horses, the NCHA does not taken any responsibility for any administered drugs prescribed for the duration of the marketing and sale period of the nomination. It is the requirement of the vendor to provide any administration of prescribed drugs during the sale period to include supporting documentation by a qualified veterinarian. The NCHA will take not responsibility and any sale may be rejected.
9. Each nomination will be charged a flat fee of \$780 (+ GST)
10. Once the entry fee has been paid the Agents fee \$250 (+ GST) is non refundable.
11. There will be no refunds on unsold or withdrawn lots.
12. Vendors will be provided with a full copy of the conditions of sale.
13. Any information supplied on the nomination form that is found to be inaccurate or misleading may result in immediate disqualification from the sale and nomination fees will be forfeited. Any vendor discovered misrepresenting a sale horse does so at the risk of being charged with a federal offence.
14. The agent reserves the right to sell the horse out of catalogue order and/or reject any horse from the sale.
15. The agent reserves the right to edit/alter catalogue notes.
16. Horses being worked on cattle are required to submit a video of the horse being worked for viewing during the Online Sale. Videos can be emailed to admin@ncha.com.au
17. Embryos must be planted into a recipient mare and the recipient mare will become the property of the purchaser. The recipient mare must provide a pregnancy certificate (signed by registered veterinarian) dated no earlier than 14 days prior to sale date. This condition also applies to natural pregnancies in broodmares.
18. Where the vendor has retained semen or embryos, this fact must be disclosed by the vendor to the auctioneer prior to the sale of the lot. These facts will be announced at time of sale.
19. A full list of eligible sale incentives, including their terms and conditions, can be found in the 2020 NCHA Select Cutting Horse Sale Online Catalogue.
20. Owners accept all responsibility for Stallions in the Select Sale.
21. Vendors or there nominated representative must be available by phone while their lot/lots are being offered.
22. **Vendors reserve price must be signed and in the hands of the Auctioneer 24hrs prior to the commencement of the auction. "No verbal instructions will be excepted"**
23. Vendors are NOT to release any horse/s until they have been contacted by the agents that funds have been received, doing so is at the vendors own risk.

Term for Purchasers-

24. No horse/s will be released without cleared funds.
25. Presale inspections are to be arranged with the respective vendors direct.
26. Payment terms, Purchaser will be invoiced at the conclusion of the sale and settlement within 24hrs of accounts. Methods of payment is by EFT direct deposit, Credit Card by phone a 1% surcharge is applicable. Booking to a stock agent but must have letter of introduction 24hrs prior to the commencement of the auction in the hands of the auctioneer.
